**Subject:- Suspension of functioning of Appellate Tribunal till 17.08.2020.**

In continuation of earlier orders dated 16-03-2020, 23-03-2020, 26-03-2020, 15-04-20, 04-05-2020, 18-05-2020, 30-06-2020 & 16-07-2020 on Novel Corona Virus (COVID-19) and in view of Ministry of Home Affairs orders No. 40-3/2020-DM-I(A) dated 23-03-2020, 15-04-2020, 17-05-2020 and 29-06-2020. As per Ministry of Home Affairs order dated 29-07-2020 directs that guidelines on Unlock 3 will be in force upto 31-08-2020.
